- I own the above golf cart and the above information is true.
- I hereby certify the following information is true and correct: **I CURRENTLY HAVE AND WILL MAINTAIN THROUGH DECEMBER 31 OF THE CURRENT YEAR ALL INSURANCE COVERAGES RELATED TO THE VEHICLE LISTED ABOVE AS REQUIRED BY THE CURRENT RULES AND REGULATIONS OF THE LAKE. (CURRENT LIABILITY LIMITS ARE \$300,000 MINIMUM FOR EACH GOLF CART OR VEHICLE REGISTERED, WHICH MUST LIST THE YEAR, MANUFACTURER AND TYPE OF VEHICLE). I will also provide within 5 days, upon request by the Lake, proof of the insurance coverages required above. I understand and agree that failure to maintain such above required coverages and/or timely provide proof of coverages requested may subject me to violation penalties, points and suspension of lake privileges.**
- Association assessments have been paid in full on all my properties.
- I agree to take all responsible precautions to prevent accident and injury to all persons and property located on the common areas.
- I indemnify and save harmless Lake Lotawana Association, their affiliates, officers, and directors from any loss and claims of damage of whatsoever kind or character, by reason of this golf cart and its maintenance while in use on the common areas.
- Golf cart travel is limited to and from applicant's boat dock using their first tier property, or in the case of second tier properties, the nearest common area easement pathway or roadway.
- Wandering up and down the parkway and traveling across surface drainage structures and wet areas is not permitted.
- Golf cart parking on the parkway shall be adjacent or near the applicant's boat dock. In the space provided at top left of this application, write where you will park your golf cart while on the parkway (nearest block and lot number).
- I agree to not cause loud noise and other disturbances while traveling on common areas.
- Golf cart shall be fitted with smooth turf type tires and if used at night, equipped with approved lighting.
- Golf cart operators shall be at least 16 years of age and a member of the applicant's immediate Single Family, as defined in the Association's Rules and Regulations.
- Golf Cart registration decal shall be displayed on the right front of golf cart and the block/lot shall be displayed on the left front of the golf cart.
- I understand that my lake privileges may be revoked and/or points assessed if my guests, family, and/or I fail to comply with the **Rules and Regulations of the Lake Lotawana Association** and this permit.
- I have read and understand all the above conditions and certify that all information above is accurate and complete.**
